



## SHEBANDOWAN SMALLMOUTH SHOWDOWN 2010 - NEWSLETTER

The 2010 Shebandowan Smallmouth Committee would like to make a brief announcement outlining a new format for the SSS tournament, 2010. Changes and other information are as follows:

The SSS 2010 will now be a 2-Day Tournament, registering 70 Teams. The Date for the Tournament this year will be JULY 17 & 18 (Saturday/Sunday).

The entry fee has been raised to \$250.

The Tournament payout format will be changed to reflect both daily prizes (for Top 5 places) as well as a larger payout in the Grand Aggregate (Top 10).

There will be no formal rules meeting this year.

In a move to make a more angler-friendly Tournament, we have dispatched the mandatory Friday-night rules meeting. Without a rules meeting, the onus is now on the angling teams to know the rules inside and out, and to abide by them. Rules are available at:
